#### **Customer Profile**

Sentara Northern Virginia Medical Center is a 183-bed hospital located in Woodbridge, Virginia. The hospital combines high tech with high touch to bring an integrated health system, medically advanced technology and quality care to the community. ### The Challenge:

As an organization that is committed to the highest level of patient care, Sentara sought to have its cancer program accredited by the American College of Surgeon's Commission on Cancer (CoC). CoC Accreditation is awarded to those facilities that have voluntarily committed to providing the highest level of quality cancer care and undergo a rigorous evaluation process and review of their performance.

CoC accreditation is a way to demonstrate commitment to providing the full scope of services required to diagnose, treat, rehabilitate, and support patients with cancer and their families. One of the most important aspects of a CoC-accredited program is a cancer registry. Registries catalog explicit, longitudinal data on cancer. This registry data is used nationwide to conduct research, evaluate best practice treatments, detect geographical trends and examine survival rates.

Yet despite their critical role, registries are often backlogged because Certified Tumor Registrars (CTRs), the professionals who perform this work, are in high demand and short supply. That makes managing a comprehensive cancer program challenging for most hospitals. CoC survey assessment and preparation; abstracting of cancer cases using established CoC, state and facility criteria; follow-up and elimination of backlogs; and general cancer registry administration are all important activities that are a necessary part of a CoC-accredited cancer program, but managing them in-house is resource-intensive, time-consuming, and often costly.

For Sentara, that is where Pyramid Healthcare Solutions came in.
